OUR RIGHT TO VOTE

Rectangle Residents Vote Closer to Home

Part of our right to vote is to have voting locations that are easily accessible, even for those among us without personal transportation. After the storm the residents of the rectangle were surprised to find their voting location was moved out of our neighborhood to a location that had poor access by public transportation and was perceived by many to be unsafe. The move out of our neighborhood was due to the fact that our normal voting location, Colton High School, was unusable due to damage and that other suitable locations were already at capacity.

Thanks to the persistence of Diane Lease and Dan Harris for keeping this issue in focus and to the leg work of John Luckett we have a guarantee from the Clerk of Courts that the voting location for the rectangle residents will be moved back into our neighborhood for the 2008 election cycle.

We would like to also thank Darrin Lombard from the Clerk of Court's Office for helping us with this issue as well as Kimberly Parker from Councilman Carter's office.



St. Claude Ave. Main Street

While we are still enduring hot, summer-time weather, you know it's coming. Fall and somewhat cooler air are coming to bring a change to our area.

St. Claude Avenue Main Street is experiencing some changes, too. Our dedicated program manager, Kina B. Joshua, who helped to launch our program is leaving the position to embark to explore new opportunities. The board is currently gathering resumés and will be interviewing potential candidates soon in the hopes that we can install a new manager by the beginning of October (when that cooler weather will hopefully begin)!

The organization is also stepping out on its own, securing our own non-profit status, and will soon function as a stand-alone organization. We'd like to thank the Renaissance Project for the support they have provided over the past year.

With all these transitions, you would think that St. Claude Main Street would be focused on that alone. Not in the least! We are currently planning our first "Main to Main" event, a state-wide series of events by all of the Louisiana Main Street communities. Our event is scheduled for Saturday November 10th and will give artists and opportunity to strut their stuff in a very public way.

Saturday, November 10 CHALK IT UP TO ST. CLAUDE

During the month of November, all 24 Main Streets in the state of Louisiana will have a MAIN to MAIN: A Cultural Road Show event. St. Claude Avenue Main Street is hosting Chalk It Up to St. Claude. The sidewalk in front of Colton Junior High School will be the target area for the sidewalk art contest. With no fees to artists, the area will be assigned to participants to design their masterpieces between the hours of 9am and 12pm. From 12pm to 4pm, the art will be judged and winners announced with prizes. We will have entertainment, food, beverages and vendors. Between the hours of 4pm to 9pm, Farrington Smith Gallery and Barrister's Gallery will be open to the public. During the course of the day, St. Claude Avenue Main Street will be collecting stories from the community on their memories and experiences of St. Roch Market.

St. Claude Avenue Main Street is seeking volunteers, food vendors and arts & craft vendors for the Fridays on the Roch and Chalk It Up to St. Claude events. In order to ensure the success, it is vital that we have individuals assisting in planning and implementation of these events. We need the expertise and energy of our community.

With the pace of rebuilding and renovating homes going strong two years after Katrina, New Orleans residents are also turning their attention to greening the city overall, landscaping property for sale, and gardening in the front yards of their newly restored homes, as well as neighborhood neutral grounds, and public spaces.

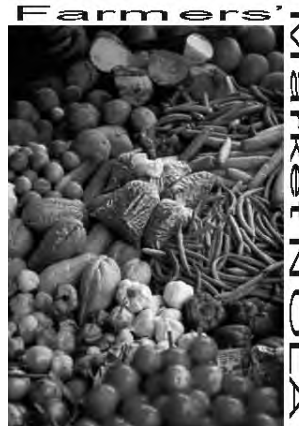

NO MORE BLIGHT

As we struggle to rebuild we realize that there are many properties in our neighborhood and our City that need to be renovated. Many of these properties are vacant and the owners have not made any attempts to repair the damage. This causes a serious safety issue for us as vagrants will break into these properties and live in them. We are taking steps to identify and document these types of properties. If you know of a property that has visible damage and/or is vacant, please let us know. 501(c)3: Here We Come

At our August General meeting we opened the floor to questions and comments on the proposed changes to the Article of Incorporation. These changes are a necessary component that will allow us to pursue non-profit status with the Federal Government. There are 5 additions that specifically relate to the nonprofit status and one addition that is meant to strengthen our organization. We will vote on these changes at our September meeting but it is very important that each member understand the changes so we can move together in this effort.

Below are a summary of the changes.

1. A declaration that we are organized for 501(c)3 charitable purposes. (ARTICLE III, A)
2. A declaration that we as members will not financially benefit from our nonprofit status. (ARTICLE IV, B)
3. A declaration that we will not use our organization for political purposes. (ARTICLE IV, C)
4. A declaration that we will not carry out any activities that are not permitted by our nonprofit status.(ARTICLE IV, D)
5. A declaration that upon our dissolution that our assets will be distributed for exempt purposes only. (ARTICLE XIV, B)
6. A declaration that individual Board members will be indemnified against legal action for decisions of the Board.
